### **Guidelines and Criteria:**

- Must be a high school senior, and either be a current Nymeo member or attend a high school located in Frederick or Montgomery County. A GPA of 3.0 or higher is required.
- Applications are evaluated on academic achievement, community service and typed or video essay.
- Winners will be contacted in May from Nymeo.

### **Application Materials Required:**

- Completed scholarship application.
- High school transcript with overall cumulative GPA.
- Resume highlighting past accomplishments, community service and other experiences.
- Essay (500 words or less) *OR* a video essay (no longer than 3 minutes) addressing the following theme:

You are the Marketing Director of Nymeo Federal Credit Union and tasked with opening 100 new checking accounts over the next three months. Your target demographic is young adults, ages 18-25, who live in the communities of Frederick or Montgomery County, MD. What strategies and tactics will you use to achieve your goal? What does your marketing plan look like?

#### **Deadline:**

Application materials must be received by the close of business on **Saturday, APRIL 15, 2023**. Scholarship applications will not be considered unless all required information is received by the deadline. Nymeo will not be responsible for lost, delayed or misdirected applications. Faxes are not accepted.
